

MINUTES OF THE MEETING OF THE COMMITTEE FOR COMPASSIONATE APPOINTMENT HELD ON DIFFERENT DATES FROM DECEMBER 2022 TO APRIL, 2023.

A Committee was constituted with the approval of Competent Authority to consider the applications for appointment on compassionate ground in ORGI vide this office's order No-56015/05/2021-Ad-V dated 20/05/2022 with the following composition: -

2. In order to consider the cases/applications of compassionate appointment received from various Directorate of Census Operations (DCOs) and ORGI (Hqrs.), the committee met on different dates from December, 2022 to April, 2023. Sh. S.N. Sharma, Deputy Secretary, presented the cases/applications before the Committee for its consideration. The Committee was apprised that the cases/applications are to be considered as per the consolidated instructions issued by DoPT vide O.M. dated 02nd August, 2022 and this office's O. M. No. A- 56015/05/2021-Ad.V dated 20th May, 2022 on compassionate appointment. The committee was also apprised that the contents of applications have been verified by DCO-Level verification sub-committee and HOO of the DCO and recommendations have been made by DCO for compassionate appointment.


3. The Committee appreciated the fact that the objective of the compassionate appointment scheme is to provide relief to the dependent family members of the deceased Government employee from the financial destitution and to help the family get over the emergency. The committee followed a 100 points weightage system containing various parameters/attributes which include family pension (20 points), terminal benefits (10 points), annual income of family members (10 points), value of moveable/immovable property (10 points), number of dependents (10 points), number of unmarried daughters (10 points), number of unmarried major son upto 25 years and son i.e. physically, mentally challenged (5 points), dependent minor children (10 points), left over service (15 points) to assess the applications.

4. The Committee went through the details of documents / information provided in the proposal of the applicants as forwarded by the DCOs/ ORGI Hqrs and awarded the marks on the basis of different attributes as mentioned in para-3 above. The details of applications considered and marks awarded to them are given in **Annexure 1**.
