MOTIF ON THE COVER





FOREWORD

The District Census Handbook (DCH) compiled by the Census Organisation on behalf of the state governments, is one of the most valuable products of the Census. The DCH is constantly referred to by planners, administrators, academicians and researchers. It is inter alia used for delimitation of constituencies, formulation of local level and regional plans and as an aid to District administration. The District Census Handbook is the only publication which provides Primary Census Abstract (PCA) data upto village level for the rural areas and wardwise for each city or town. It also provides data on infrastructure and amenities in villages and towns, etc.

The District Census Handbook series was initiated during the 1951 Census. It contained important census tables and PCA for each village and town of the district. During 1961 Census the scope of the DCH was enlarged and it contained a descriptive account of the district, administrative statistics, census tables and a village and town directory, including PCA. The 1971 DCH series was planned in three parts. Part-A related to village and town directory, Part-B to village and town PCA and part-C comprised analytical report, administrative statistics, district census tables and certain analytical tables based on PCA and amenity-data in respect of villages. However, in some states it was confined to district census tables and in a few cases altogether given up due to delay in compilation and printing.

While designing the format of 1981 DCH series some new features alongwith the restructuring of the formats of village and town directory have been attempted. At the same time, comparability with the 1971 data has also been kept in view. All the amenities except power supply in the villages have been brought together in the village directory with the instruction that in case an amenity is not available in the referent village the distance in broad ranges from the nearest place where the amenity is available may be given. The restructuring of the format of the village directory and incorporating more exhaustive data on infrastructure aspect particularly in relation to amenities and land-use pattern is expected to further meet the need of micro level planning for rural areas. It is expected to help not only in local area planning but regulating the provision of goods and services as well as to minimise the regional imbalances in the process of development. A few new items of information have also been introduced to meet some of the requirements of the revised Minimum Needs Programme. Such new items of information as adult literacy centres, primary health sub-centres, and com-

munity health workers in the village have been introduced in the village directory with this objective in mind. The new item on approach to the village is to have an idea about the villages in the district which are inaccessible. A new column, "total population and number of households" has been introduced to examine the correlation of the amenities with the population and number of households they served. Addition of two more appendices listing the villages where no amenities are available and according to the proportion of scheduled castes and scheduled tribes population to the total population has also been made with this view in mind.

The formats of the town directory have also been modified to meet the requirements of the Minimum Needs Programme by providing information on a few new items. A few statement on civic and other amenities in slums in Class-I and Class-II towns (Statement IV-A) has been introduced with this objective in mind. It is expected that this will help the planners to chalk out programmes on provision of civic amenities for the improvement of slums. The columns on scheduled castes and scheduled tribes population in statement IV relating to civic and other amenities and adult literacy classes/centres under educational facilities in statement V are also added inter alia with this view. A significant addition is class of town in all the seven statements of the town directory. The infrastructure of amenities in urban areas of the country can be best analysed by taking the class of towns into consideration. The addition of the columns on civic administration status and population in a few statements also served this purpose.

The format of the primary census abstract for the villages and towns has been formulated in the light of changes in the economic and other questions canvassed through the individual slip of 1981 Census.

In order to avoid delay in publication of 1981 DCH series it has been so designed that Part-A of the volume contains village and town directory and Part-B, the PCA of villages and towns including the scheduled castes and scheduled tribes PCA upto tehsil/town levels. At the beginning of the DCH a detailed analytical note supported by a number of inset tables based on PCA and non census data in relation to the infrastructure has been introduced to enhance its value. The district and tehsil/Police Station/C.D. Block etc. level maps depicting the boundaries and other important features have been inserted at appropriate places, to further enhance the value of the publication.

ANALYTICAL NOTE

ANALYTICAL NOTE

On May 13th 1974 Tengnoupal district was formed out of the erstwhile Central district. The district falling between 25° North latitude and 95° East longitude and encompassing an area of 3,375 sq. kms. is the newest of state's districts having been carved as such for ensuring administrative convenience. The district is made up of three constituent sub-divisions. Tengnoupal, Chandel and Chakpikarong which at the 1961 Census formed part of Manipur district. The district has 255 villages the most populous of them being Machi village with the population of 842 persons as per 1981 Census. The next biggest village is Lamlong Khullen which has a population of 785. The district has one town i.e. Moreh Small Town.

District Census Handbook and its scope : The District Census Handbook is the innovation of 1951 Census which brought down the Census data to the town and village level. Until then Census presented data mostly upto district/sub-divisional/Town level only. This innovation, perhaps was prompted by the realisation of the need of the data at the grass-root level for data users both for administrative planning and academic studies. The District Census Handbook innovation of 1951 continued undisturbed in 1961 presentation with a few addition to it. However, in 1971 it was further realised that the combination of Census and non-census data in a single publication as was the precedent from 1951 onwards became unwieldy and it delayed the timely publication of Census results. Therefore it was felt that the Census data should be delinked from the non-census data and the publication should be brought out in two volumes. First volume deals with the village and town directory and also the village Townwise Primary Census abstract of the district. The second volume deals with the non-census data and social economic and cultural tables.

In 1981 Census there has been a further slight innovation wherein the District Census Handbook consists of only one volume which contains village and town Directory in Part A and in Part B Village/Townwise Primary Census Abstract of the concerned district.

The District Census Handbook of 1951 contained apart from Census data the other general information about the district like physical, socio-cultural and administrative aspects of the district which included both the Census and the non-census data. In 1961 the scope of District Census Handbook was sought to be made more comprehensive by including certain additional items and dividing the entire presentation into four parts. First part dealt about the land and the people, second part

contained Census tables. Third part the information regarding agriculture, medical and health etc. Fourth part contained village/Town Directory.

Already stated, the District Census Handbook underwent further innovation in 1971 Census wherein it was split up into two volumes. First dealing with the village and Town Directory and also town/villagewise Primary Census Abstract of the district. Second part dealt with non-Census data and other socio-cultural and economic tables.

In 1981 Census , with a view to avoid delay in bringing out the publication and also to streamline the publication programme the second part of 1971 Census Handbook has been omitted. Thus the present volume of District Census Handbook will bring about the village/Town Directory in Part A and in Part B Town/Village-wise Primary Census Abstract of the concerned district. Part A village Directory will contain information about the name of the village, total area of the village, total population and number of households in the village, amenities like education, medical, drinking water, Post and Telegraphs, communication, power supply, village market, and the distance from the nearest town etc. This part also contain information about the socio-cultural aspects like food habits of the people, land use in the village forest, irrigational resources, cultivable waste and the places of religious, historical and archaeological interest. Similarly Town Directory contains seven statements which would deal with area of the town and number of households population and rate of the growth of the town during the last eight decades, density of the population of the towns, sex ratio status of civic administration, its finances and other socio educational cultural and developmental activities and the amenities that might have been undertaken or provided. As already stated Part B would contain Town/Villagewise Primary Census Abstract which includes information/data about the total area of the village, occupied residential houses, total number of houses, total number of households, population and its sexwise break-up so also the break-up of scheduled castes and scheduled tribes, literacy and the break-up of the population by sex into four broad industrial categories like cultivators, Agricultural labourers, household industries other workers. Apart from the aforesaid data, the Primary Census Abstract will contain data in the marginal workers and non-workers also.

It would be pertinent to mention here that the sources of information for the Town and the Village Directory have been mainly the revenue agency supplemented by the concerned departments like education, medical, co-operation and the local bodies. The information so collected from the various sources have been thoroughly scrutinised so as to ensure its authenticity.

CENSUS CONCEPTS

In order to understand the precise import of the meaning of the words used in the analysis of data in the publication, it would be pertinent to briefly explain the census concepts and definition of various terms used.

Village : The term village for the purpose of 1981 census has the same definition as in the previous Censuses. A village with separate name and situated within a defined boundary for the purpose of Census of 1981 as well as being hamlets are treated as a village unit.

In the Primary Census Abstract of 1971 Census a column had been added which showed various amenities available to villagers. During 1971 Census this column had been replaced by fullfledged table village Directory which gives details of various amenities and land use of the village. In 1981 Census the same pattern has been adopted with some modification and alteration. The statement for village Directory briefly shows the area of the village, its position vis-a-vis various amenities such as Educational, Medical, Power Supply, drinking water, communication postal and Telegraph facilities etc, 16a to 17b show the land use with break-up of land by first irrigated and unirrigated area, culturable waste and area not available for cultivation. Another column i.e. column 12 gives the name and distance of the nearest census town. This column is to study the economic and cultural impact of the town on the village.

Census Town : The criteria for determining a Town in 1981 were generally the same as adopted in 1971 Census. The criteria are (i) all places with a Municipality, Corporation or cantonment board of notified area Committee and (ii) all other places which satisfied the following criteria :

- (a) Minimum population of 5,000 persons.
- (b) at least 75% of the male working population should be non-agricultural.
- (c) density of population of at least 400 sq. kms.
i. e. 1,000 per sq. mile.

The Director of Census of each State/U.T. is however, given some discretion in respect of some marginal cases in consultation with the state Government to include some places that had other district urban characteristics and to exclude undeserving cases.

Scheduled Caste and Scheduled Tribes : The names of caste and tribes recognised as scheduled caste and scheduled tribes in Manipur for the purpose of Census are given in the scheduled caste and scheduled tribe lists (modification) order 1976 issued by the President of India. The list so far as it applies to Manipur is reproduced below :

PLACES OF ARCHAEOLOGICAL, HISTORICAL AND TOURIST INTEREST

Moreh : A frontier station on the Indo-Burma boarder this place is about 72 kms. from Chandel district is one of the promising town and also tourist centre. It has a police outpost on custom checkpoint and a small Inspection Bungalow. It is said to have been used in earlier days as a penal settlement for women who committed murder.

Chakpikarong : Situated on a point along the southern boundary of the district, this place is about 12 kms. to the west of Sugnu. It has a newly constructed Inspection Bungalow and a small Bazar. Chakpi river is famous for its scenic beauty.

Chandel : Situated on the border between Burma border and it is the district headquarters of Tengnoupal District. Recently a new Inspection Bungalow was constructed to accommodate the tourist there. A beautiful hill station it is situated at a height of 3,200 feet above the sea level.

Physical aspects of the district : The Tengnoupal district is one of the newest of the state's districts having been carved out as such for ensuring administrative convenience. The district is bounded on the north by the Central District on the east by East District, on the south by Burma on the West also by Burma.

Rainfall : The district enjoys an adequate amount of rainfall. The distribution of rainfall is higher in the district than in valley while the average annual distribution of rainfall at Chandel, the district Headquarters is 3,104.00 mm. that for Moreh is 3,121.0 mm while some rain occurs in all the months of the year most of rain falls during the period from April to October.

Fauna : A variety of fauna is found in this district. Among the larger kinds leopards, elephants, wild pigs are commonly found in almost all parts of the district. Among the smaller animals that are commonly found in the district are monkeys, rats and others. Among the game birds found in the district are jungle fowl, snipe, quail, duck, geese and teal.

Flora : Inspite of the limited area covered by the district the vegetation is rich and varied in character. The district which has boundaries with Burma naturally share the flora of the neighbour. *Albizia spp (khok)* *Aquilaria (Agor) cashanopsis spp (sawl)* are some of the important flora found in the district.

Forestry : The Burma border forest lie at the Indo-Burmese border of the district. The Kabow Valley marks the eastern boundary of these forest. The rich alluvial bank of the river of this district are congenial to the growth of peak. The hills which slopes down the Kabow Valley are not so high and at places are only a few hundred and at places are only a few hundred feet above the ground. Besides teak are came across, oak and Eng in these forests. Evergreen forests mixed with multi-bamboo also appear towards the southern portion of these forests.

Mineral resources : As yet no thorough geological investigation has been conducted in the district to find out the potential resources. It is generally held that the district is poor in mineral resources.

Agriculture : The utilisation of land resources forms an important subject in any programme of economic planning in predominantly agricultural economy. Unfortunately and utilisation statistics are not available for the district as it has not been cadastrally surveyed.

The main crop is paddy and nearly 95 per cent of the total area under cultivation is paddy but the area under this crop is not available. There are no large sized holding in this district on account of scarcity of cultivable land acquisition. The basic holding under Manipur Land Revenue and Land Reform Act 1960 is $2\frac{1}{2}$ acres.

Agricultural season : In the valley ploughing is generally done in the month of April and May after first showers of year softened the soil. More intensive ploughing is carried on in June and July when the rain set in. There are two modes of cultivation in the valley namely (i) punghul and (ii) transplantation of seeds.

In the hill area Jhum and terraced cultivation are carried on, the agricultural season and operations naturally vary from place to place. But in general the land is cleared in the month of January and February; crops are sown in May-June and harvesting starts in October and ends about the early part of December.

Animal husbandry : Livestock is the chief wealth next to agriculture only to the majority population of the district. Every house invariably keeps a few cows and pigs. According to the livestock census conducted in 1976 there were 3,426 animals including buffaloes. This number according to 1979 rose to 4,748 animals.

The improvement of bread livestock is the main concern of the department of Animal Husbandry in the district which indeed has taken a considerable stride in its improvement. There were 2 (two) veterinary Hospitals and two veterinary Dispensaries in the district. During 1978-79 two artificial insemination centres were opened at Chandel and Chakpiarong. 1,000 cows were inseminated. Prophylactic inoculation against contagious deseases was given to 1,200 animals. Touring dispensaries were also set up.

Dairy : In order to improve the overall standard of living the Animal Husbandry Department has been focussing its attention for increasing the dairy milk in the district. With the aforesaid point in view the department has initially started milk supply at Chandel Town by keeping some cross breed animals at Japhou.

Poultry farming : For the first time in January 1979 central poultry farm was established by the animal Husbandry department with a view to rear improved breed/strain of poultry birds and distributed those birds to the farmers of the district. During 1980 two additional centres called poultry extension at Chakpiarong and poultry rearing and marketing at Liwachaning were set up. Further the extension work was instructed to the development blocks in the initial stage. However, in the second stage duck yard poultry units in the ratio of one male and four females were propagated and distributed through the development blocks under the scheme applied nutritions programme (ANP).

Fisheries : At the district level one District fishery officer is responsible for the fishery development of the District.

There is one fish breeding-cum-fish distribution centre at Chandel. The stocking tanks are used for keeping the brood fishes. (a) The Indian Major Carp (b) Cypiness Carpio for use of multiplication of fish seeds locally. In 1978-79 this Department produced locally 4000 fingerlings of common carp and 2,600 fingerlings of Mirror carp from its fish breeding centre at Japhou. Though there are rivers in the hill areas none of them has been registered for fishery. Fishing as a regular occupation is unknown to the people of the district but some of them however catch fish during September and October from Maha Lokchao, and Chakpi river. New exotic fishes like Mirror carp and common carp which had been recently introduced are very popular as they grow very fast and also breed in confined water areas.

Transport and communication : Road communication of the district is very poor and inadequate. But there is a phenomenon increase from 1971 to 1978 in the mileage of inter-village road. National Highway No. 39 Kamagoan-Moreh Road passes through the district and the total mileage of this road within the territorial limit of the district is 63 kmps. This road was widened and considerably improved by the P.W.D., Manipur. Burma-Sugnu Road Motor

Owner's Co-operative Society maintains 12 Buses connecting Chandel and Chakpikarong, and Moreh with the rest of the state. Manipur Road Transport Corporation maintained 4 buses plying on different bus routes of the district. There are also numerous bridgepalm in the hill sub-division of the district which connect the villages. The construction of inter-village paths, maintainance of existing bridge paths. Construction of small suspension bridges and building of rest camp come under the provision of Tribal Welfare and Public Works Department, Manipur.

Houses : Both stilt and plinth type of houses are found in this district. Stilt houses has an elevation of 4 ft. from the ground and raise plinth has 2 to $2\frac{1}{2}$ ft. from the ground. Bamboos and planks are the main skeleton of the house. However with the spread of education and improved socio-economic conditions people are shifting to R.C.C. houses instead of traditional houses..

Furniture : Traditionally in Tengnoupal sub-division, bedsteads are not used. Floor of the house is made of planed wooden planks. However in Chandel and Chakpikarong sub-division some households use bedsteads. Cloths are commonly kept in the wooden chest in the hills and Trunk and boxes in the plain area of the District. But with the passage of time and the modernisation the distinction is getting narrower and any well-to-do household anywhere in the district has modern furniture available in the house.

Food and dress : Rice is the staple food of the people of the district. Generally two meals are taken in a day one in the morning and the other in the evening. In both the meals the item of food taken are more or less similar. If a household wishes to take tea it is prepared with or without milk. Tea drinking is now a common practice.

There is no difference in dress between ethnic groups or between economic status groups or between persons of different ages. Married, unmarried and widowed persons do not necessarily wear any specific dress in order to be distinguished from one another. Nowadays western type of dresses are very popular in the district.

Trade, Commerce & Banking : The Tengnoupal district has never been a great trading centre. The trade and commerce is continued to the local requirements only. The chief business centre are Moreh, Chandel and Chakpikarong. Kakching one of the chief business centre of the Central district lies 15 kms. away from Chandel, the district H.Q. Moreh is also one of the flourishing business centre which lies at Indo-Burma border. The local products especially cane and bamboo works are displayed at Moreh and Chandel.

There are two branches of State Bank of India one at Chandel and another at Moreh. There is also a branch of United Bank of India at Chakpikarong.

Industries : Tengnoupal district has practically no industry worth the name a few rice Mills which cater the need of the people. But rural cottage industries like weaving, carpentry, cane and bamboo works and basket making etc. are being encouraged through government help United Bank of India is also providing loans to the small scale industries.

Community Development : There are three Development Blocks. The Sub-divisional Officers are acting as Block Development Officers in their respective Sub-divisions. These Blocks look after at last technically and provide subsidies for the purchase of improved seeds furniture, agricultural implements, distribution of rear seeds and improved breed of cattle.

Co-operation : There are 23 Co-operative Societies functioning in the district until 1978-79. However their role has yet to reach in the public since at present they do not have any activity worth the name except civil supplies distribution. There is an Apex Co-operative Society called Apex-Co-operative Society Chandel, plays a predominant part in bringing into the district the customers item.

Working population : According to 1981 Census 52.16 per cent population has been classified as main workers. The main worker will be defined in the later stages as (1) who primarily works for 183 days or more in a year. The main workers according 1971 Census were 61.14 per cent. This downward trend can be partly due to the fact that with the spread of education more people at the young age go for schooling and higher studies than to assist the parents in tilling the land and secondly it would be reasonable to attribute to the influx of vast number of Government servants whose family largely attend to domestic course only. Despite, the downward trend of main workers, it is still higher compared to the state percentage of 40.35. This is primarily because of the entire district being a rural area and the economy based on agricultural operations alone.

Horticulture : Since late seventies the district has made considerable stride in the field of horticulture. The pineapple orchards are located predominantly in Chandel sub-division where different varieties of pineapples grow. Arum is grown all over the district. Orange cultivation has also not lagged behind.

In order to provide a market for horticulture products, the state government have started a fruit processing unit at Chandel. There is a privately run fruit processing unit at Moreh. The cultivation of coffee has recently started at Tengnoupal sub-division.

The plant protection centres are located at Chandel and Chakpikarong under technical guidance of the Agriculture department. Horticulture department is responsible for getting nursery to the orchardists on a reasonable rate for which the government as well as the private registered nurseries. Under the component plan loans and subsidies are provided on the supply of plants, fertiliser and pesticides. The subsidies are to the extent of 50 per cent in case of scheduled castes and scheduled tribes and backward classes, 83 per cent to the marginal farmers and 25 p.c. to the small farmers.

Irrigation: Though the entire Tengnoupal district is ornamented by the rivers and rivulets nonetheless due to the difficult topographical conditions not much headway has been made in the matter of irrigation. With the creation of separate Irrigation Deptt. by the Manipur Government special emphasis is being laid to construct and improve small canals. The implementation of Minor Irrigation scheme is the responsibility of the Irrigation Deptt. In 1978-79 the Planning Commission had allotted a sum of Rs. 2 lakhs for the improvement of irrigation system in Tengnoupal District.

Literate: A person who can both read and write with understanding in any language is to be treated as literate. A person who can merely read but cannot write is not a literate. It is not necessary that a person who is literate should have received any formal education or should have passed any minimum educational standard. Children upto the age of four years have been treated as illiterate irrespective of whether they attend the school or not.

Worker: Work is defined as participation in any economically productive activity. Such participation may be physical or mental in nature. Work involves not only actual work but also effective supervision and direction of work.

Main worker: A person who has primarily worked for a major period of the year is a main worker. By the major part of the year, it is intended to find out that the person has worked for 183 days or more or in other words worked for six months or more.

Marginal worker: A person who has worked for less than six months or 183 days but worked for less than six months or 183 days but worked at least a day during the year before enumeration is considered as marginal worker.

Non-worker: A person who has not worked at all during the preceding one year from the date of enumeration is non-worker.

Cultivator: A person is a cultivator if he or she is engaged either as employer, single worker or family worker in cultivation of land owned or held from the government or held from private person or institution for payment of any money, kind or share. Cultivation includes supervision or direction of cultivation

Agricultural labourer: A person who works in any person's land for wages and money, kind or cash is regarded as an agricultural labourer. He or she has no risk in cultivation but he or she merely works in another person's land for wages. An agricultural labourer has no right to lease or control on land on which he/she works.

Household industry: It is an industry which involves at least manufacturing or processing or servicing or repairing conducted by the head of the household himself/herself and or by member of household at home or within the village in rural area and only within the premises of the house where the household lives in the urban area. The large proportion of the workers in a household industry should consist of members of the household including the head. The industry should not be run on a scale of registered factory which would qualify or has to be registered under the Indian factories act.

Other workers: All workers i.e. who have been engaged in socio-economic activities during the one year who are not cultivators and agricultural labourers or in household industry are other workers. The type of worker under this category includes factory workers, plantation workers, those in trade and commerce business, transport, mining, construction, all government servants, municipal employees, etc. In fact, all those who work in the field of economic activities other than cultivation, agricultural labour or household industry are other workers.

Employer: An employer is a person who has to employ a person in order to get work performed, i.e. such person is not responsible for his or her personal work but also giving work to others for carrying out the economic activities.

Employee: An employee is a person who usually works under some other persons for salary or wages either in cash or kind. There may be person who are employed as managers, superintendents, agents etc. and in that capacity employ or control other workers on behalf of their own employers, such person are only employees not employer.

Single worker: A single worker is a person who works by himself/herself. He/she is not employed by anyone else and in his/her turn does not employ anybody else. This definition of single worker will include a person who works in joint partnership with one or several persons having no employees and also a member of producers co-operative with one of the partners or members of said producers co-operative.

Family worker—A family worker is a member who without receiving wages in cash or kind, in an industry business, in a trade or service. For example, the working member in a family of Dhobi where they all work and each does not receive wages separately will be family worker. There may be family workers in industry, trade. Family worker must be related by ties of blood

or marriage but such workers can belong to different households. What is important is that such workers must necessarily be related even though they may be living in different households. The family workers may or may not be entitled to share the profit in the work or business carried on either by person or head of the household or the relative.

ANALYSIS OF DATA

It would be of interest to analyse the 1981 Census data which would reveal many interesting developments in the district during the decade. Table 1 gives sub-division-wise number of villages and population in the district. There are 254 inhabited villages with a population of 56,444 on the sunrise of 1st March 1981. Of this 56,444 persons 29,174 males and 27,270 females. Table 1 would reveal that Tengnoupal Sub-division has got 97 villages next comes Chakpikarong with 85 inhabited villages and lastly Chandel with 72 villages.

In terms of population too, Tengnoupal Sub-division tops the list with a population of 25,666 out of which 13,498 are males and 12,168 are females. Next comes Chakpikarong Sub-division with the population of 15,730. Of this 8,010 are males and 7,720 are females. Chandel Sub-division runs third with a population of 5,048 and of this 2,666 are males and 2,382 are females.

Table 2 given below reveals the decadal changes in the distribution of population. As stated earlier the population increase during 1971-81 in Tengnoupal maintains its lead 47.60 p.c. Next followed by Chandel Sub-division with a growth rate of 44.59 per cent. Chakpikarong Sub-division with the decadal growth rate of 43.96 percent has registered the lowest growth rate amongst all the three sub-divisions of Tengnoupal District.

It may not be possible to precisely pinpoint the abnormal growth rise in the Tengnoupal Sub-division. However it can partly be due to the fact that the influx of migration is caused by the government servants and traders who flocked in these two sub-divisions.

The low growth rate in the Chakpikarong Sub-division are partly because of the severity of climate which makes the population mostly seasonal and another factor is lack of job opportunities.

Table 3 given below deals with the distribution of villages by population ranges. Unlike many of the other villages in the state, Tengnoupal district has only 169 villages with the population of less than 200 thereby registering a 66.54 per cent villages with a total population less than 200. As many as 74 villages which comprise 29.13 percent of the total fall in the range of 200 to 499 followed by 11 villages with percentage village of 4.33 in the range of 500 to 1999.

Table 4 given below indicates the percentage of scheduled castes population to the total population in the villages. Out of 254 inhabited villages in the district 230 of the villages have no scheduled caste population at all and in another 23 villages the scheduled caste population ranges upto 5 per cent only. In respect of the village the percentage ranges 31 and above.

Table 5 given below gives the proportion of scheduled tribes population in the total population in the villages. In 1981 census the scheduled tribe population of the district constitute 68.09 per cent of the total population compared to 89.04 per cent in 1971 census. 167 villages in the district has a scheduled tribe population of 65.75 per cent and above. Next 9 villages have a scheduled tribe population in the range of 36-50 per cent. Only 3 villages fall in the range of 26-35 and more below it.

Table 6 shows the proportion of scheduled castes and scheduled tribes population in the town of the district. Moreh Small Town Committee with a population of 7678 persons has only 2355 scheduled tribe population. There is no scheduled caste population at all and percentage of scheduled tribe for the town being 30.67 to the total population.

Table 7 gives literacy rate by population ranges of the villages. There are 169 villages with the population of less than 200 persons in each villages which has a combined literacy rate of 31.47 per cent. Another 74 villages in the population range of 200-499 have a literacy percentage of 33.91. Lastly 11 villages in the population range of 500-1999 have a literacy rate of 35.18. The aforesaid percentages reveal that smaller villages have a lower percentage of literacy whereas larger villages have higher percentage of literacy.

Table 9 shows the percentage of Scheduled Castes/Scheduled Tribes, literates, main workers, marginal workers, total workers and non workers to the total population in the district. Scheduled Castes and Scheduled Tribes constitute 0.33 per cent and 68.09 per cent of the total population in the district, literates, main workers, non workers, total workers and marginal workers constitute 34.23 per cent, 54.60 per cent, 45.33 per cent, 54.67 per cent and 6.07 per cent of the total population. The percentage of urban population for scheduled tribes is 30.67. The literacy for urban population is 40.86 per cent. The percentage of main workers, total workers, non workers for urban population are 32.46, 32.46 and 67.54 respectively. There is no marginal worker for urban population at all.

Tables 10 and 11 deal with the distribution of villages according to the availability of different amenities and proportion of rural population served by different amenities respectively.

Tengnoupal district has 254 inhabited villages with the population of 56,444 persons. Of this 211 villages in the district 83.07 per cent of the villages have got educational facilities of one type or the other. Similarly another 20 villages constituting 7.87 per cent of the total inhabited number of villages in the district have got medical facilities of one type or the other. All the 254 inhabited villages of the district have got drinking water facilities of one type or the other. In respect of Post and Telegraph facilities 18 or 7.09 per cent of the village have either Post Office or Post and Telegraph Offices with phone or without. Communicationwise 13 villages or 5.24 per cent of the villages in the district have been connected by Bus service. This apart, 22 villages or 8.66 per cent have been connected by pucca road.

Table 12 deals with the distribution of villages having certain amenities arranged by distance range from the places where these are available. There are 43 villages in the district without any sort of educational facilities. Out of these 42 villages have this facility of one type or the other within a distance of less than 5 kms. from the respective villages. Another 1 village has the facility within 5-10 kms.

All the inhabited villages of the district have drinking water facility within the village. Post and Telegraph facility as in case of medical facility, the district appears to be badly placed in that 236 have no post and telegraph facility itself 28 villages have the facility within 5 kms. 47 villages have the facility within 5-10 kms. 161 villages have it beyond 10 kms. Communicationwise 241 villages have no communication facility. Of this 21 villages have the facility at less than 5 kms. distance and next 44 villages have this service within 5-10 kms. and the remaining 176 villages have to travel beyond 10 kms. to catch the bus.

Table 13 deals with the distribution of villages according to distance from the nearest town and availability of different amenities. In the district 12 villages are within 5 kms. distance from the nearest town. Of this, all the 12 villages have the educational facility within the village itself, 3 villages have the medical facility. All villages have the drinking water facility, 1 village has Post and Telegraph facility, 2 villages have bus stands, 6 villages have their approach through pucca roads and none of the villages has electricity facilities. Another 65 villages are situated within the distance range of 6—15 kms. from the nearest town. Of this 52 villages have educational facility, 4 villages have medical facility. All 65 villages have drinking water facility in the village itself. 10 villages have their approach through pucca roads and no village has been electrified, 175 villages are within the distance range of 16—50 kms. from the nearest town. Of this 146 villages have educational facility, 13 villages have medical facility. All 175 villages in this range have drinking water facility, 12 villages have Post and Telegraph facility and 6 villages have communication facility within the village itself, 6 villages have approach by pucca road and none of the villages has been electrified.

Table 14 deals with the distribution of villages according to population range and amenities. In the range of 499 and less, there are 200 villages which have educational facility in the villages itself, 18 villages have medical facility, all 243 villages have drinking water facility, 15 villages have Post and Telegraph facility, 11 villages have communication facility, 19 villages have approach by pucca road and no village has been electrified.

There are 11 villages in the population range of 500-1999. Of this 11 villages have educational facility, 2 have medical facility, 11 villages have drinking water facility, 3 villages have Post and Telegraph facility, 2 villages have communication facility, there is no village which has power supply.

Table 16 indicates the growth, density, sex-ratio of urban population in the district in relation to the state during the four censuses. Tengnoupal district had a percentage of urban population of 13.60 per cent during 1981 Census. As already mentioned earlier the district itself is a new district carved out from Central District of Manipur. The corresponding state Urban population was 0.50 per cent, 8.68 per cent, 13.19 per cent, 26.24 per cent in the censuses of 1951, 1961, 1971 and 1981 respectively. Since we cannot get area figure of the district and town we cannot calculate, density of population. The sexwise ratio in the urban area in the district as well as in the state is always overwhelming, in favour of male compared to females.

VILLAGE DIRECTORY

Village Directory which is one of the traditional documents of Census has been canvassed during the 1981 Census too, on the basis of information collected the village Directory schedule can broadly be divided into three parts. The first deals with the basic amenities available to a village like the education, medical, drinking water, post and telegraph, communication, power supply and market etc. In this part it has been sought to ascertain whether the above facilities exist in a village and if it does then to what extent/level. If the above amenities are not available then the nearest distance from the nearest village/town where the aforesaid facilities/amenities are available has been noted.

The second part deals with the land use which has been endeavoured to conform to the pattern of classification of land use as recommended by the Ministry of Food and Agriculture, Government of India. The source of information for the aforesaid data had been the revenue records shown/converted into hectares.

The third part of the village Directory deals about the information of the places of historical, archaeological and religious importance in a village. This apart it also deals with the socio-economic level of the people. It also endeavours to gauge social and cultural level of the people by para-metres like the number of motor cycles, scooters, jeep cars, and tractors available in the village and the number of newspapers inform to the village.

The first part dealing with the amenities needs elaboration which given as under :—

(a) Educational amenities

The various levels of the educational amenities provided in a village has been shown for the sake of convenience in the abbreviations given as under :—

In the aforesaid health centres of various levels Family Planning advice and clinical facilities may also be available which havc' not been shown separately. If there are more than one institution of same type in the village the same have been indicated in numbers against the abbreviation e.g. H(2), D(3) etc. In view of a variety of medical amenities for which a number of codes as above has been suggested, it would not be possible to provide too many details under each such amenity. Thus all registered Medical Practitioners whether Ayurvedic, Unani or Allopathic have been covered under the Code 'RP'. It would be appropriate to mention that the terms "Community Health Workers" does not refer to workers in extension programmes like Malaria eradication, Agriculture etc. It refers to only those paramedical personnel who have been trained dispensing medicines for minor ailments. Where no facility is available within the village a dash (—) has been shown in the relevant column. But next to it in the brackets the distance in the broad ranges viz.—5 Kms, 5—10Kms, and 10 +Kms. of the nearest place where the most modest medical amenity like Dispensary, Community Health Worker, Primary Health Centre or Primary Health Sub-Centre or Hospital is available has been given.

Nearest town and distance : The distance of the nearest town is given in Kms. in brackets. This has been filled in purely on the basis of local enquiry. The nearest town so indicated need not be within the state itself. The nearest town in even in another states have been indicated wherever necessary alongwith the name of the State. Further operational convenience has been taken into consideration while showing the nearest distance of the town.

Electricity Supply : If the electricity is actually available whatever may be the form of its use it has been shown as available. The Codes used for various category of electricity are as under :—

- (1) Electricity for domestic purpose only —FD
- (2) Electricity for Agriculture purpose only —EAg.
- (3) Electricity for other purposes like industrial, commercial, etc. only —EO
- (4) Electricity for all purposes listed above —EA

Staple food : Here the term staple food has been used only in terms of grains and no other food material. The name of the grain consumed by the inhabitants for the major part of the year has been treated as staple food of the inhabitants. Where it was not possible to pin-point the foodgrain or in other words, where the inhabitants have been using more than one type of foodgrain more than one name has been given.

Land use : As already stated the total area of the land in its 5 (five) broad categories has been compiled from the revenue records. In the first category, types of land under forests has been indicated and in the second and third information about the cultivated area, irrigated and un-irrigated has been shown. The irrigated area has been further split up as per the sources of irrigation. Fourth being the area under cultivable waste which includes meadows, groves and pastures. Lastly the area not available for cultivation such as residential area, paths and uncultivable land waste etc. has been given.





SECTION II—TOWN DIRECTORY

As already dealt in the preceding pages, the information about Town Directory is being presented in six statements each dealing with a particular set of information in respect of all the urban areas of the district. Certain improvisation have been carried out in comparison to 1971 Census Town Directory to most of the statements keeping in view the requirement of data for various purposes and convenience for the analysis.

The Statement I relates to the status and growth of the towns since 1901 Census. This statement has been divided into two parts. The first column I to 5 deals with locational and area particulars. Whereas column 6 to 19 deal with the demographic particulars. The column 6 gives number of households including houseless households whereas column 7 to 15 gives population of town since 1901. The column 16 gives density of population per sq. kms. as per 1981 Census. Column 17 to 19 depict sex ratio in three Censuses since 1961 Census. In this statement class of town area in sq. kms. and number of households density and sex ratio since 1961 are the new addition.

Statement II deals with the physical aspects and location of towns. Broadly the statement can be divided into two parts. First dealing with rainfall and temperature data (Column 3—5) while in the second part (Column 6—12) name and distance from the State Headquarters. District headquarters, Sub-divisional headquarters. Nearest city with a population of one lakh or more Railway Station, Bus route and navigable river/canal have been presented in each town. In column 2 the class of town has been added this time to facilitate the analysis.

The rainfall data has been obtained from the table published by the Directorate of Statistics and Economics. Information for other columns have been obtained from the Local Bodies.

Statement III relating to civic administration status and Municipal finance for the year 1978-79 has been presented in this statement. In column 3 the civic administration status in 1980 has been given whereas in column 4 to 10 income of local bodies from various sources has been presented and in column 11 to 17 expenditure on various items is given. These figures have been given in '00' with a view to save the printing space. The class of town has been added in column 2, information for this statement has been collected from the concerned local body.

Statement IV contains 19 columns. Column 2 to 6 are the new additions to this statement. The statement on the one hand depicts general information about the towns like class of town, population, Scheduled Caste and Scheduled Tribe population and road length in kms. on the otherhand elicit information relating to system of sewerage. Number of different types of latrine, method of disposal of night soil, protected water supply availability of Fire Fighting Service and number of electric connection of different types system of sewerage and method of disposal of night soil are being presented upto two methods wherever available in order of importance and information on number of private latrines is based on estimates as no actual information was available with the local authorities. The categorisation of electric connection is based on the record maintained by Electricity Department, Govt. of Manipur.

Statement V—In this statement information relating medical facilities, educational facilities to recreational and cultural facilities has been presented. Broadly this statement can be divided into four parts. In part one particular relating to class and population has been given. Part two which contains column 4 and 5 relates to various types of medical facilities and number of beds in each type of medical institution. Column 6 to 15 deals with the various type of educational facilities available. Whereas these facilities were not available the distance from the nearest place where it is available has been given. It may also be mentioned here that in case of composite schools like Higher Secondary Schools having high, middle and primary classes the same have been considered against each level. In column 15 the other includes institutions like Sanskrit etc. The fourth part deals with the column 17 to 20 wherein particulars relating to recreational and cultural facilities have been presented.

Column 2 and 3 deal with class of town and column 15 and 16 deal with Adult literacy centres and working women's hostel with number of seats are the new addition this time. Information for this statement has been collected from the Director of Medical and Family Welfare, Director of Education and Director of Statistic & Economics and respective local bodies.

Statement VI—The statement depict information relating to three most important commodities imported, exported and manufactured, number of banks and number of Agricultural and non-agricultural Credit Societies. All the columns of 1971 Town Directory have been relating and the columns relating to the class of Town have been added this time. The commodities have been mentioned in order of volume, information for this statement has been primarily collected from the Director of Industries and concerned Departments and concerned local bodies.

For determining the class of towns the population of each town during 1981 Census has been considered. The following are the ranges for determining the class of town.
