## **Notification**

- **G. S. R...-** In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Deputy Director General (Information Technology), in the Office of the Registrar General, India, namely:-
  - 1. Short title and commencement. (1) These rules may be called the Office of the Registrar General, India, Deputy Director General (Information Technology)- Group A Post, Recruitment Rules, 2021.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
    - 2. Number of post, classification and level in the pay matrix. The number of the said post, its classification, level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule to these rules.
    - 3. Method of recruitment, age limit, educational qualifications, etc.- The method of recruitment, age limit, educational qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the aforesaid Schedule.
    - 4. Disqualification.- No person,-
    - a. who has entered into or contracted a marriage with a person, having a spouse living; or
    - b. who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:
      - Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
    - 5. **Power to relax.** Where the CentralGovernment is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
    - 6. **Saving.** Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Fifteen years post qualification experience of electronic data processing or experience of actual computer programming or software development or data base management system or web designing or networking or organizing computerized information storage and retrieval system or e-governance applications or Project Management skills and Information and Communication Technology expertise or data security in a Government office or public sector undertaking or an autonomous or statutory organization or universities or in any recognized institution.

OR

(B). All India Service Officers or Group-A service officers holding a post in level-14 of the pay matrix (Rs.1,44,200-2,18,200/-) on regular basis in parent cadre or department with four years' experience in the area of e-Governance.

Note: The Period of deputation(ISTC) including the period of deputation (ISTC) in another *ex-cadre* post held immediately preceding this appointment in the same or some other organization / department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 58

	years as on the last date of receipt of applications.
