Sealed Limited Tenders are invited from reputed manufacturing firms or their authorized dealers, suppliers fulfilling the following minimum eligibility criteria and as per the terms & conditions given below, only on prescribed form at Annexure-I for civil, electrical, data cable work, supply & fixing of furniture in the Directorate of Census Operations, Delhi, C-Wing, Ground Floor, Pushpa Bhawan, Madangir Road, New Delhi-110062.

- **1. ELIGIBILITY CRITERIA FOR BIDDERS:** The Bidders intending to participate in the tender process should fulfill the following minimum eligibility criteria.
- (a) Average annual turnover of the bidder should be more than Rs. 1.0 crore during the last three year. Audited Balance sheets for 2010-2011, 2011-12, 2012-13/2013-14 as support papers should be submitted;
- (b) The bidder must have undertaken and successfully completed at least three important similar projects (given at point no 2 of Annexure I) each valuing rupees 15.00 lakhs or more during the period April, 2011 to March, 2014 in the offices of Government of India/State Governments/Public Sector Undertakings/any other reputed companies. Copies of such Work Orders during the above mentioned years alongwith completion certificates. (Certificates should be submitted with the quotation)
- (c) The Bidder should not have been blacklisted by any Central Government /State Government Offices, PSUs and the bidder should not have been bankrupt from any of the bank or any financial institution. (Self-declaration certificate to this effect separately must be submitted)

The manufacturing firms or authorized dealers suppliers with agreement or joint agreement are not allowed to bid.

(d) The firm should be ISO 9001: 2000 certified. (A valid certificate copy of the same must be enclosed)

Note: The bidders can visit the site during office working days (for calculation of area etc.)

- **2. SCHEDULE OF OFFER**: Sealed limited Tenders are invited for the civil, electrical, data cable work & supply & fixing of furniture as per the prescribed specification of materials and approximate quantity indicated in at Annexure-II.
- **3. AVAILABILITY OF TENDER DOCUMENT:** Tender Document can be obtained from the Directorate of Census Operations, Delhi. The same can also be downloaded from www.censusindia.gov.in (Tender).
- **4. DUE DATE:** Due date for submission of offer is on or before 3:00 P.M. on date 26.08.2014 at Directorate of Census Operations, Delhi, Offers received after due date and time of submission shall not be considered. The Tender will be opened on date 26.08.2014 at 3:30 PM.
- **5. OFFERS:** Intending firms should submit their information in prescribed proforma at Annexure -I. It should be addressed to the purchaser i.e. "The Director, Directorate of Census Operations, Delhi. If tenders are submitted by hand then sealed envelope must indicate TENDER NO. & DUE DATE OF OPENING and shall be deposited in the TENDER BOX provided for this purpose. If the tenders are sent by post, then tender must be sent in double covers. INSIDE COVER should have TENDER NO. & DUE DATE OF OPENING AND SEALED while OUTSIDE COVER should only bear address of the purchaser without mentioning tender number & due date of opening and need not be sealed. TELEGRAPHIC/FAXED QUOTATIONS SHALL NOT BE ACCEPTED.
- **6. RATES:** Rates should be indicated in Indian currency including all charges like all taxes, loading- unloading, installation, freights etc. The rates quoted must be firm till delivery, Statutory deductions will be made from the bill payments.
- **7. VALIDITY:** Prices quoted must remain firm and offer should remain open for acceptance for six months from the date of opening of tender.
- **8. ERASING, OVER-WRITING AND CORRECTIONS:** Erasing, over-writing and corrections should be authenticated by the tenderer's signature. In case this has not been done such offer is likely to be rejected. All tender document & enclosures are to be signed with date & stamped.
- **9. DELIVERY/COMPLETION SCHEDULE:** The Successful bidder is to start the work immediately from the date of issue of Work Order/Job Assignment and by the purchaser it is expected from the bidder to complete the work not later than 60 days. To this effect the bidder should mention the delivery/completion schedule in the prescribed bid proforma else it will be rejected by the purchaser as non-responsive.
- **10. LATE DELIVERY:** In case work is not completed within time schedule then this office reserves the right to recover liquidated damage charges @ 0.5% of the complete value per day.

11. RISK PURCHASE: In case of failure to completion of work within the stipulated schedule, as per para 10, this office reserves the right to undertake risk purchase at the cost of DEFAULTER. Any additional expenditure so incurred in undertaking risk purchase shall be recovered from the Defaulter. In this context, we also reserve our right to cancel part of the order and undertake risk purchase for this cancelled quantity depending on our need.

12. EARNEST MONEY DEPOSIT (EMD):

EMD is to be enclosed with tender document Conditions regarding deposit of EMD are as given below:

- (a) Bidders are required to deposit Rs. 40,000/-(Rupees Forty Thousand Only) towards EMD in the form of Account payee Demand Draft/Pay Order/Bank Guarantee of any Nationalised/Scheduled Bank drawn in favour of "THE DIRECTOR, DIRECTORATE OF CENSUS OPERATIONS, DELHI" payable at New Delhi along with Bid. No. Public Sector Unit or Joint Sector Unit is exempted from paying Earnest Money.
- (b) Any bid without Earnest Money in the form mentioned in 12 (a) will be rejected by the Purchaser as non-responsive.
- (c) Unsuccessful Bidders Earnest Money will be discharged/returned as promptly as possible but not later than 30 days after the expiration of the period of bid validity prescribed by the Purchaser.
- (d) The successful Bidders Earnest Money will be discharged/returned after the retention amount of 10% of bill amount rounded upto the next hundred.
- (e) No interest will be payable by the Purchaser on the amount of the Earnest Money.
- (f) Failure of the successful Bidder to comply with the requirement /job order shall constitute sufficient grounds for the annulment of the award and forfeiture of the EMD, in which event the purchaser may make the award to the next lowest evaluated Bidder at the risk and cost of the successful Bidder.
- 13. PAYMENT & "PERFORMANCE SECURITY" 90 % of the total amount can be released after completion of work of the Supplier and to the satisfaction of the Purchaser shall be paid to the Supplier and the remaining 10% of the bill amount rounded upto the next hundred shall be retained by the Directorate of Census Operations, Delhi towards "Performance Security". The total retention amount against bills of the Supplier, retained, towards "Performance security shall be released by the Directorate of Census Operations Delhi after the warranty period of two year from the date of completion of work. No interest will be payable for the retention amount towards "Performance Security". In the event of non-providing the

services, the retention amount shall be forfeited to the extent the services are not provided. Further, if the Purchaser has to get the services from any other Bidder because of failure to provide in full or part by the successful Bidder, the difference in payment may be made from such amount. Also, the amount retained towards "Performance Security" is subject to forfeiture if it is found at any point of time during warranty period that the materials used by the Supplier are not in conformity to the accepted specification by the Purchaser or substandard.

Note: Earnest Money will be discharged/returned to the Supplier when the retention amount @ 10% of bill amount towards "Performance Security" by the Directorate of Census Operations, Delhi would exceed the EMD Value.

- **14. SALES TAX /VAT CLEARANCE CERTIFICATE:** A copy of latest sales tax/Vat clearance certificate duly self-attested should be submitted along with the offer.
- 15. BANK CHARGES: Bank charges, if any, shall be borne by the successful tenderer.
- **16. DELIVERY & INSTALLATION:** The material should be properly delivered in conformity with the specification and properly installed to the satisfaction of the purchaser and concerned authority within a period of sixty days.
- 17. LATE OFFER: Any offer received after due date of opening and time are not acceptable.
- 18. ATTENDING TENDER OPENING: The representative of the tenderer who wishes to attend to the tender opening is allowed to do so subject to presenting the authorization letter from the tenderer.
- 19. PROVEN SUPPLIER: Please enclose copies of work orders and completion certificates received from offices of Government of India/State Governments/public sector undertaking and any other reputed limited companies for civil work, electrical work, data cable work, supply & fixing of Modular Furniture valuing more than Rs. 15 Lakh as proof of proven vendor.
- **20. GUARANTEE**/ **WARRANTY:** The materials should carry minimum Guarantee/Warranty for two year from the date of completion of work
- **21.** The material used in the work should be of standard quality and must be of a branded one.
- 22. AWARD CRITERIA: The purchaser shall award the Job Contract to the successful Bidder whose bid has been determined to be responsive and has been determined as the lowest evaluated bid on the basis of quoted rates for the estimated quantity of materials (ANNEXURE-II) Provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily. The Purchaser shall however not bind to accept the lowest or any bid and reserves the right to accept any bid, wholly or in part. The Purchaser at its absolute and sole discretion reserves the

right to award contract to more than one Bidder for the purposes as may be necessary or expedient.

23.
