Subject : Tender enquiry for procurement and delivery of about 1,00,100 PVC/Plastic Polythene bag with adhesive tape – Regarding.

Sealed quotations are invited from the manufacturers of PVC/Plastic Polythene bag with adhesive tape as per specifications attached at Annex-A. Interested bidders are requested to quote their competitive rates in the following manner.

2. The PVC/Plastic Polythene bag are required urgently and to be supplied within 10 days from the date of placement of the order. The delivery of the PVC/Plastic Polythene bag with adhesive tape is to be made at Okhla Industrial Area, Phase-I and the validity of rates will be 1 (one) year.

3. Your quotation per unit (inclusive of all taxes) of the PVC/Plastic Polythene bag as per proforma attached (Annex-B) in sealed envelope along with an EMD of Rs. 10,000/- (Rs. Ten thousand only) in the form of Demand Draft/Pay Order of any Nationalized/Scheduled Bank drawn in favour of "Pay & Account Officer (Census)" payable at New Delhi should reach the undersigned by 25.4.2014 up to 3.30 p.m. Quotations received after the stipulated date/time and without EMD shall not be entertained. Quotations shall be opened at 4.00 p.m. on the same day in the presence of the representative of the firms, if any. The order would be placed to the lowest bidder (L-1) based on the per unit rate. The EMD of successful bidder (L-1) shall be forfeited if it does not accept the work for any reason, whatsoever. The EMD of successful bidder will be converted as Performance Security till completion of the work. EMD of unsuccessful bidders will be returned as promptly as possible as but not later than 30 days.

4. This office, however, reserves the right to reject any or all quotations without assigning any reason thereof along with the right to amend any of the tender conditions or a part thereof before the last date for the receipt of the tender if found absolutely necessary. Any such amendment will be communicated to the tenderers.

5. Besides the items mentioned above in the bid, the following should be enclosed along with the tender in a sealed cover :

- a) EMD of Rs. 10,000/-.
- b) Attested copy of the firm's Registration renewed up to date.
- c) A copy of latest Sales Tax/VAT clearance certificate duly self attested.
- d) Self certificate duly signed by the tenderer that the tenderer has not been blacklisted either by ORGI or any Central/State Govt. or its undertakings.
- e) Details of Bank Account including bank's name, branch and account No. with IFSC/RTGS/MICR code of the Branch.
- f) A sample of the PVC/Plastic Polythene bag with adhesive tape as per specification are to be supplied separately, before the opening of the bids. Firm will produce a self attested certificate that material used is of the same specifications as per Tender Notice's Annex-A and submit the same at the time of delivery of PVC/Plastic Polythene bags.
