Re - Tender Notice

In view of non-receipt of sufficient Tenders, the Tender call notice of even no. / 3115 dated 24.02.14 is hereby cancelled. Sealed quotations are, therefore re-invited superscribing "Quotation for UPS Batteries" are invited by the Office of the Director of Census Operations, WB, Kolkata, from the Manufacturers/registered dealers of batteries for supply and installation of 64 Nos. of 65AH batteries (30 minutes battery backup) for replacement of battery bank of online modular UPS installed at our Data Centre, Janganana Bhawan, IB-199, Sector-III, Salt Lake City, Kolkata – 700 106 as per specification herebelow.

The quotations should be submitted as per prescribed proforma (Annexure-II)

1) Eligibility Criteria:

The bidder should be a manufacturer or registered dealer of batteries of reputed brands.

Supplier of batteries should have a local office to attend the complaints immediately. The following Papers / documents should be enclosed with the Tender.

Note: Original Product catalogue should be attached with the bid and product should be available on OEM website.

- Rate: The rate shall be quoted for each battery including Buy-back of old batteries (Panasonic make Model LCX1265NA) available in this office. The Buy-Back value will be deducted from the cost of new battery. The rate shall also include all taxes, door delivery and installation charges. All taxes and transportation cost for lifting the material and for buy back shall be borne by the vendor themselves.
- 4) Quotation Validity: The rate shall be valid for at least Six months from the date of tender.
- Due Date: Quotations in the prescribed Format alongwith all annexures should reach this office on or before 14-03-2014 by 3.00 PM. The tender received after the due date and time will not be considered. The tenders will be opened on the same day (i.e. 14.03.2014) at 4.00 p.m. in presence of the representatives of the bidders, if any.

- 6) <u>EMD:</u> Earnest Money Deposit (Bid Security) of Rs. 10,000/- (Rupees Ten thousand only) shall be submitted by means of Demand Draft from a nationalised bank/scheduled commercial bank drawn in favour of "Director of Census Operations, West Bengal" payable at Kolkata along with the quotation. The quotation will not be entertained without EMD.
- Delivery Schedule: Total 64 Nos. of 65AH batteries are required to be supplied within 15 days from the date of supply order through door delivery to the Director of Census Operations (Data Centre), "Janganana Bhawan", IB-199, Sector-III, Salt Lake City, Kolkata 700 106. All the batteries to be supplied should be new and of good quality. In case of delivery is not made within the specific time the EMD will be forfeited.
- 8) Payment: Payment will be made by cheque only after the delivery and successful installation of batteries and on submission of satisfactory certificate from the Data Centre. Pre-receipted bill in triplicate are to be submitted.
- Performance Security: The successful Tenderer awarded with the job shall be required to deposit Performance Security equivalent to 10% of the total value of the work order rounded up to next thousand within seven days from the date of receipt of work order, in the form of Account Payee Demand Draft / Pay Order / Banker's Cheque / Bank Guarantee from a Nationalized / Scheduled Commercial Bank in favour of "Director of Census Operations, West Bengal" payable at Kolkata. On request of the Tenderer, the Earnest Money Deposit (EMD) will be adjusted against the Security Deposit payable by the Tenderer and the Tenderer shall deposit the balance amount in the prescribed mode and specified time limit. If the Security Deposit is not paid within the time specified, the Earnest Money Deposit of the Tenderer shall be forfeited. In such case, DCO West Bengal shall be entitled to get the work executed from elsewhere and recover the consequential loss sustained from the Tenderer due to getting the work executed either through some other Tenderer or through the Tenderer selected through the process of re-tendering. The "Performance Security" shall be released by DCO West Bengal after three years of successful completion and to the satisfaction of the DCO West Bengal. No interest will be payable for "Performance Security". In the event of nonproviding of the services, the Performance Security shall be forfeited to the extent that the work has not been completed as per specified specifications and to the satisfaction of the DCO West Bengal. Further, if the DCO West Bengal has to get the work completed from any other Tenderer because of failure to complete the work in full or part by the successful Tenderer, the difference in payment may be made from such amount.
- 10) Special Note: The tenders submitted earlier has not been opened. As such, those firms, who had participated earlier, need not send fresh EMD of Rs. 10,000/-. They may, however, revise their rates, if so wished. Any relevant document, if not submitted earlier, may be submitted afresh.

Any dispute pertaining to this tender is subject the Kolkata jurisdiction only. The Joint Director reserves the right to cancel any or all the tenders without assigning any reasons thereof.
