

3. Other terms and conditions are as given below:-

- a) Sealed Bids should reach this office latest by **3:00 PM of 31.08.2015** Bids received after the specified date/ time shall not be entertained.
- b) Bids shall be opened on the same day at **3:30 PM** in presence of the firms or their representatives, if any.
- c) The details of maximum days of delivery & installation should be mentioned in the bids.
- d) Quoted rate should be valid for minimum period of **six months**.
- e) The exact quantity will be decided at the time of issue of Supply Order, which may vary from the quantity indicated here.
- f) A copy of latest Sales Tax/ VAT clearance certificate, duly self-attested, should be submitted along with the quotation.
- g) Bank charges, if any shall be borne by the successful tenderer.
- h) The material should be properly delivered in conformity with the specifications and properly installed to the satisfaction of the concerned user.
- i) **The firm should submit the tender specific authorization letter from OEM.**
- j) The successful bidder should be in position to supply and install the above item within **15 days** from the date of issue of the work order.
